1. Introduction/介绍

- 1.1 Juno Markets 20% Deposit Bonus is a campaign conducted by Juno Markets Limited (herein the "Company") to clients under the following terms and conditions. / Juno Markets 20% 存款奖金是 Juno Markets Limited(以下简称"公司")根据以下条款和条件对客户开展的一项活动。

2. Conditions of Eligibility/资格条件

6. General Terms / 一般条款和条件

- 6.1 In the event that any Eligible Client maintains an open position in the trading account(s) during the submission of a withdrawal request, the same conditions apply to the bonuses as the above clauses. In these circumstances, the Company reserves the right, at its sole discretion, to close/suspend (either temporarily or permanently) all such Eligible Client's real trading Account(s) with the Company, cancel all orders and annul all profits of such participant. In these circumstances, the Company shall not be liable for any consequences of the trading bonus cancelation, including, but not limited to, order(s) closure by Stop Out. /如果公司自行决定,任何形
